Sealed Tenders are invited from reputed vendors on behalf of Society Of Civil Engineers (SOCCE), the Departmental Academic Society of Civil Engineering Department of IIEST, Shibpur for supply of food packets on "Cultural Nite" to be held on 16th March,2016.

19th February (Friday), 2016 at 1300 Hrs.

DATE AND TIME OF OPENING OF BIDS:

19th February (Friday), 2016 at 1600 Hrs.

REQUIREMENTS AND SPECIFICATIONS:

- → Total number of food packets will be 250 pckts (180 Non.veg + 70 Veg)
- → Each food packet shall contain adequate food for one person.
- → The menu will be-

Non Veg.- Fried rice (Plain), Chicken chap/curry/kosa, chatni & misti. Veg.- Fried rice (Plain), Butter paneer, chatni & misti.

→ The foods shall be properly packed and hygienic.

INSTRUCTION TO BIDDERS:

The Successful Bidders are expected to provide the above mentioned foods subjected to the following conditions:-

- 1. The above mentioned food packets will be received by the undersigned on 16.03.2015 on behalf of SOCCE.
- 2. The food packets should be freshly made and packed.

The Bidder shall provide qualification information which shall include:-

- 1. The bidder should provide Valid Trade Licence (renewed up to current financial year e.g. 2015 2016) along with Company / Proprietor Pan Card as applicable.
- 2. The bidder need to submit Valid Service Tax Registration / VAT Registration as applicable.
- 3. The bidder need to submit Documentary proof of Income Tax Return of at least one (1) year from last three (3) financial years.
- 4. The bidder should submit duly signed and self-attested declaration that, the bidder hasn't been blacklisted by any organisation for performing below standard.

Bid Price

- a) The bid shall be for the whole work including delivery of food packets.
- b) The bidders are required to quote their price, in amount of INR only for the whole work.
- c) All duties, taxes and other levies payable by the vendor under the contract shall be included in the total price
- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.

Submission of Quotations

- 1. The quotation submitted by the bidder shall comprise the following:
 - (a) Quotation in the format given in Annexure-1
 - (b) Qualification information duly completed.
- 2. The bidder shall seal the quotation in an envelope addressed to "General Secretary, Society Of Civil Engineers, Department of Civil Engineering, Indian Institute of Engineering Science and Technology, Shibpur, Howrah-711103.
- 3. The envelope will also bear the following identification: -

- 4. Quotations must be received in the Office, Department of Civil Engineering, Indian Institute of Engineering Science & Technology, Shibpur, Howrah-711103 latest by the specified time and date.
- 5. Any quotation received by SOCCE after the deadline for submission of quotations will be rejected and returned unopened to the bidder.

OPENING OF QUOTATIONS

Quotations will be opened in the presence of Bidders or their representatives who choose to attend at the specified time and date in the office of SOCCE.

PRIVACY OF BIDS

Information relating to evaluation of quotations and recommendations for the award of contract shall not be disclosed to bidders or any other persons not officially concerned with the process until the award to the successful bidder is announced.

EVALUATION OF BIDS

The Employer will evaluate and compare the quotations (the gross amount i.e. exclusive of all taxes) determined to be substantially responsive i.e. which -

- (a) Meet the qualification criteria specified above,
- (b) Are properly signed, and
- (c) Conform to the terms and conditions, specifications without deviations.

AWARD OF CONTRACT

The Employer will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price and who meets the specified qualification criteria. Notwithstanding the above, the Employer reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
