Bidder shall furnish an undertaking for providing Comprehensive onsite warranty for any manufacturing defect for a period of minimum one year for the furniture from the date of supply/installation on their letter head, failing which, their offer will not be considered.

The date of delivery for supply of the **Furniture item** will be two weeks from the date of issue of the purchase order.

#### Details of Items:

## Steel Office Almirah (large)- 2 No.

Size of the almirah must be 1980mm(H) x 915mm(W) x 480mm(D) [78"x36"x19"] having four shelves making five compartments without locker. Doors of almirah must be made of 1mm thick CRCA sheet providing 6 lever good quality locks, Body of the almirah must be made of 1mm (20gauge) thick CRCA steel sheet. It should be mutli welded with co2/tig welding.

All steel parts shall be pretreated for nine stage anti- corrosion treatment followed by powder coating of thickness 50-60 microns complete.

#### Small Almirah- 1 No.

Size of the almirah is 1250 (Ht.) X 750 (W) X 430 (D) having three shelves making four compartments without locker. Doors of almirah must be made of 1mm thick CRCA sheet providing 6 lever good quality locks, Body of the almirah must be made of 1mm (20gauge) thick CRCA steel sheet. It should be mutli welded with co2/tig welding.

All steel parts shall be pretreated for nine stage anti- corrosion treatment followed by powder coating of thickness 50-60 microns complete.
