CIRCULAR

This is for information to all concerned that as per the O.M. No. 19024/1/2009-E. IV dated 13 July, 2009 issued by Department of Expenditure, Ministry of Finance, Govt. of India, mandates that air travel should be undertaken by AIR INDIA, in all cases of air travel (i.e. on official tour or availing LTC as the case may be) both domestic and international, where Government of India bears the cost of air passage. Further the Para. 3 of the said OM stipulates that in all cases of deviation from above mentioned order because of operational or other reasons or on account of non-availability, individual cases may be referred to the Ministry of Civil Aviation, Govt. of India for availing of relaxation.

Amendment to the above mentioned O.M. on 16 September, 2010, further states that air tickets may be purchased directly from the Airline (at the authorized booking counters/official website of the concerned Airline) or by utilizing the services of authorized travel agents viz. M/s. Balmer Lawrie & Company, M/s. Ashok Travels and Tours and IRCTC.
