The bidder needs to submit Valid Service Tax Registration, VAT Registration as applicable. 3. The bidder need to submit Documentary proof of

Income Tax Return of at least one (1) year from last three (3) financial years. 4. The bidder should submit duly signed and self-attested declaration that, the bidder hasn't been blacklisted by any organisation for performing below standard.

#### **Bid Price**
