Model No. and Brand must be clearly mentioned in the quotation, without which quotation will not be considered.

Bidder shall furnish an undertaking for providing Comprehensive onsite warranty for any manufacturing defect for a period of minimum one year for the furniture from the date of supply/installation on their letter head, failing which, their offer will not be considered.

The date of delivery for supply of the **Furniture item** will be **two weeks** from the date of issue of the purchase order.

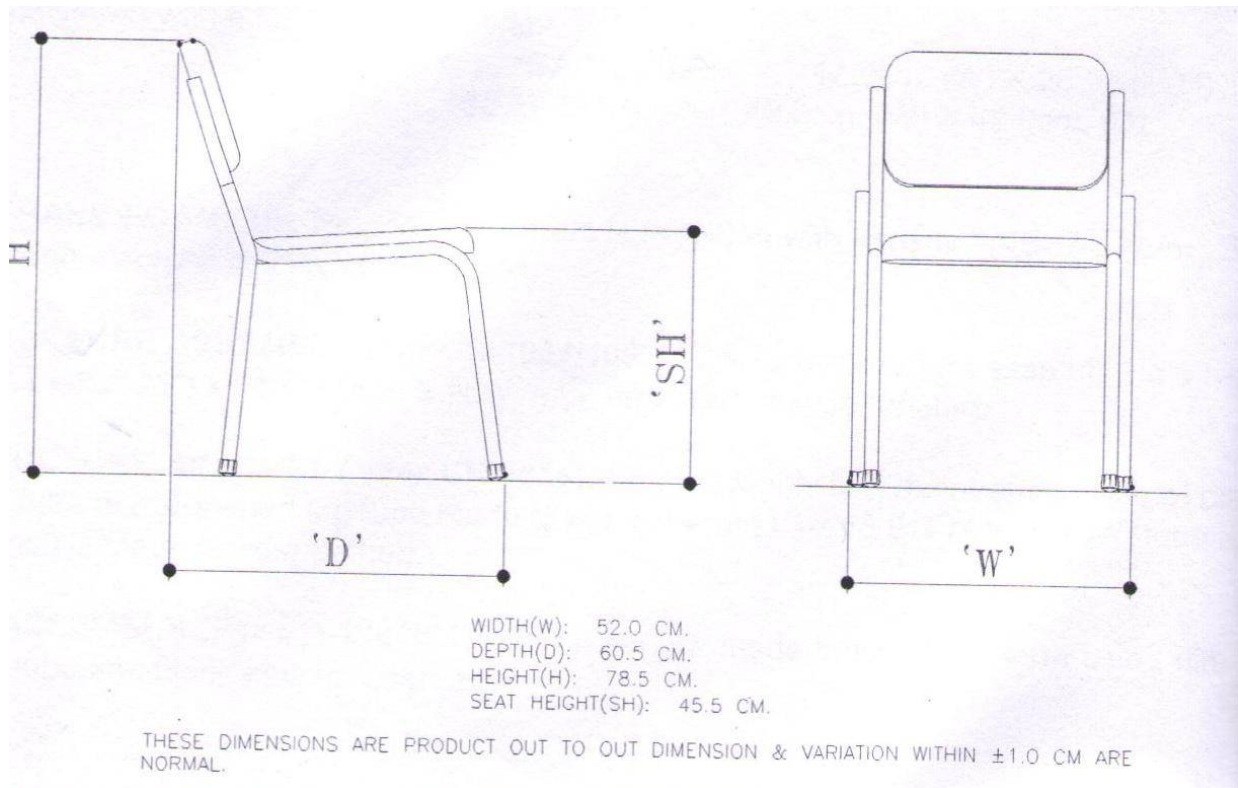
Cushioned Chair (Brand Godrej./ Bombay Safe/Wipro) – 30 Nos.

Specification for cushioned chair:

1. Seat/Back assembly: The seat and back are made from 1.0 cm thk. hot pressed water resistant, commercial plywood upholstered with P.U. foam and fabric.

Back size : 42.0cm(W) x 26.5 cm (H), Seat Size : 42.0 cm (W) x 42.0 cm (D)

2. Polyurethane Foam: The Polyurethane foam is moulded with density= 45+/-2 Kg/m and hardness = 20 +/-2 kg on Hampden machine at 25 % compression.
3. Understructure Assembly: The assembly is a mainframe made of dia. 2.54 cm. (1") x 14 BG M.S. E. R. W. tube and a welded leg tube made of dia. 2.54 cm. (1") x 18 BG M.S. E. R. W. tube to the form the complete assembly which is black powder coated.
4. Diagram of chair is as follows:
