The date of delivery for supply of the **Furniture item** will be two to three weeks from the date of issue of the purchase order.

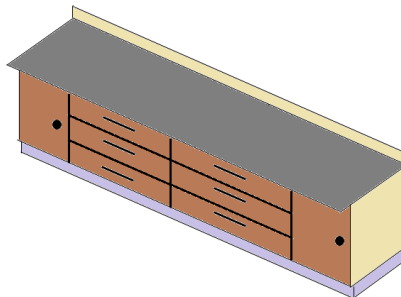
TECHNICAL SPECIFICATIONS OF ITEMS :

ITEM-1: Ply made laminated table with granite top having drawers and cabinets

Specification:

- Dimension: [8´x 2´6´´x 3´(L x W x H)], basic structure will be with 19 mm ply
- 10-12 mm granite top [8´2´´ x 2´8´´ (L x W)]
- Middle and side support will be with 19 mm ply
- 2 nos. of storage cabinets in both side having three working racks [Each cabinet dimension ~1´6´´x 2´6´´x 2´9´´(L x W x H)]
- Doors of side storage cabinets and each working racks should be made with ply (12 mm)
- 6 nos. of drawer with ply (12 mm): ~2´6´´x 2´6´´x 10´´(L x W x H)
- Each drawers should have steel channel and locking facility
- All the ply to be used in these work should be either "Century ply" / "National ply"

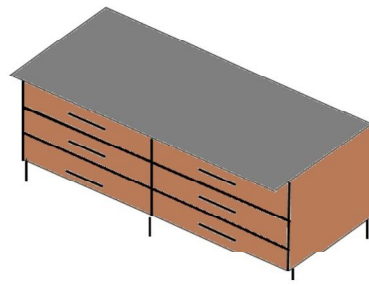

ITEM-2: High strength table with drawer

Specification:

- Dimension: [6'3''x 3'3''x 3'(L x W x H)], basic structure will be with 19 mm ply
- Middle and two side support (vertical) will also be of 19 mm ply. Table top ply should be of 19 mm
- Drawer with ply (12 mm): 6 nos. each having dimension of ~3'x 2'6''x 10''(L x W x H)
- Each drawers should have steel channel and locking facility
- **Should be able to withstand ~ 120 kg load**
- Rubber sheet on table top [6'3''x 3'3'(L x W)] - Thickness of rubber sheet 10 mm
- Legs: 3'x 2'' (L x W)
- A cross-section of 2'x 1'' (W x H) should be present in the middle for support
- Leg rest should be of 2'x 1'' (W x H)
- Table overhang should be of 3'x 1'' (W x H)
- All the ply to be used in these work should be either "Century ply" / "National ply"

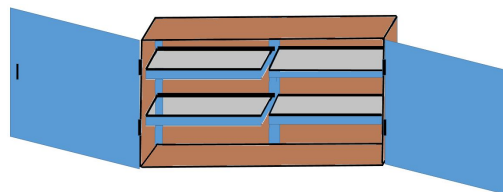


ITEM-3: Storage rack with ply

- Dimension: [3'x 1'x 2'6'' (L x W x H)] with 12 mm ply
- No. of working shelves- 3
- Plywood (12 mm) doors with lock facilities
- All the ply to be used in these work should be either "Century ply" / "National ply"
