However, before taking up the agendum he informed that he received a letter from the Secretary, Indian Institute of Engineering Science and Technology,

Shibpur Teachers' Association (IIESTTA). The Senate noted the content of the letter and opined that the Senate is competent to take decision in such matters.

The Senate resolved to review the calculation of percentage of attendance in view of certain discrepancies pointed out by some members and other relevant points raised by a few members, as per following guidelines:

1 Emergency Meetings of the Senate shall not be considered for the purpose of arriving at

aggregate attendance.

2 If a meeting is held in multiple sessions (as is the case when a meeting is adjourned to subsequent date (s)), presence in any of the sittings would be considered for attendance.

3 Members who cannot attend a meeting on account of being deputed on official duties by the Institute outside the campus would be considered as present.

4 Leave of absence would not be considered as the member being present in the meeting.

It was desired that the Registrar shall recalculate the attendance of Senate members in accordance with the revised norms stipulated above, and get them officially endorsed by the respective members before circulation.

Decision on agenda-item no. 20.01 was deferred for the next meeting of the Senate.
