## **SECTION-I: General Conditions and Important Instructions for Bidders**

1. Interested parties/vendors are to download the tender documents with detailed specifications from the institute website ([www.iiests.ac.in](http://www.iiests.ac.in))
2. It is necessary to submit the original tender documents along with technical/price bids in sealed envelopes to the **Head, Department of Civil Engineering, Indian Institute of Engineering Science and Technology (IEST), Shibpur; Howrah-711 103**, or directly to **Drop** in the **Tender Box** kept in the Department.
3. Bidders are to abide by the terms and condition and submit this tender document in original duly signed with acceptance of the terms and conditions.
4. The rate should be quoted in rupees per copy of proceedings. GST components should be mentioned separately.
5. Last date of receipt of tender is December 12, **2018 (4:00 pm)**. Tenders received late will not be accepted under any circumstances. Tenders will be opened in the Seminar Hall of the Civil Engineering Department, on the same day at 4:15 pm. In case the Institute remains closed on the said date, tenders will be opened on next working day at 12:30 p.m.
6. The Price Bid should clearly mention the price including the following:
  - Delivery charges up to IEST, Shibpur, Howrah, including loading and unloading charges.
  - Necessary arrangements/logistics for serving lunch is to be made by the vendor at location suggested by the conference organizers, if and when required.
  - All taxes, duties, levies applicable.
  - Erection, Commissioning and testing charges at IEST, Shibpur site
7. The goods/services are to be supplied at the Department of Civil Engineering, Indian Institute of Engineering Science and Technology between 1.00 p.m. and 3.00 p.m. before 16<sup>th</sup> December, 2018.
8. Bills in triplicate should be presented for payment within 15 days of supply/ commissioning of work. No advance is paid for execution of the order. The Purchase Order No. is to be noted on both Challan and Bill. All bills are to be accompanied by order copies and Challan receipt.
9. Payment will be made on submission of Proper Bills, Challans etc, by A/C Payee Cheque and no cash payment will be made under any circumstances.
10. All payments are subjected to statutory deductions as and when applicable.
11. Tender is to be kept valid for acceptance for 1 month with effect from the last date of issue of the tender without any modifications in its terms and conditions.

## **SECTION –II : SPECIFICATION**

1. The size of the Proceedings book will follow A4 format.
2. There will be paper-back (semi-hard) cover, out of which front and back cover will be colour printed both outside and inside. There will be printing in back cover (both inside and outside).
3. There will be maximum 10 inside coloured pages for advertisements and those will be placed at different sections of the Proceedings book.
4. The total nos. of Text pages would be maximum 150 pages and those would be printed in black (i.e. without any colour).
5. The publishing materials will be given latest by 13<sup>th</sup> Dec., 2018, both in MS-Word and PDF.
6. The cover design layout as well as final proof needs to be confirmed from the Organizers at least 2 days before the printing process starts.
