Change of Department on the basis of the result of 1st year in the academic session 2018-19.

Application is invited from the students, admitted in July 2017 and completed their 1st year course for the change of their department.

The following are the salient points of this scheme.

- Applicable to top 20% students(See the list) of all UG (Engineering and Technology) disciplines excepts Architecture with the following conditions:
 - Has no record of Supplementary / Fail/Re-Admission etc
 - Not involved in events leading to disciplinary action
 - No pending dues
- Restricted to 5% increment of the total seats in any discipline
- Reduction in the number of students will not be more than 10 % in any case for any department.
- Top 20% calculations is done on the base value of the approved seats in each department (See the table below) and the CGPA up to 2nd semester.
- Allocation logic is based on the preference on the CGPA, choice of the department, restriction on reduction of the number of students in a particular department. To break the tie on same CGPA the marks of Mathematics , Physics and Chemistry will be used , in that order .

Students are invited to submit their choice, excluding his/ her parent department, to a maximum possible of 8 departments, in order of preference.
