#### **Name of the work:**

Supply of **Conference Table for Conference Room of Director** of the Institute.

#### **Description of item:**

Sealed quotations are invited by the Professor-in-Charge of Furniture, Indian Institute of Engineering Science and Technology Shibpur, Howrah 711 103 for supply of **1(One) no.** Conference Table, as per given specification. The rate shall include the cost of tables, delivery charge, etc. All taxes, duties, levies applicable – to be shown separately.

#### **Item Specification:**

**Supply and fixing OVAL SHAPE CONFERENCE Table** with the following specifications.

The table is to be supplied in completely knock down conditions for assembly at site.

The construction of the main table shall be free standing structure constructed with the help of minifix dowels and pins. The table should be made of 36mm MDF board +4mm veneer pasted of desired shade finished with Natural polish finish & back side of the top pasted with balancing laminate. Table should have matching edge band. MDF board shall be of Interior Grade II as per IS 12406: 2003. The table connections have to be made in such a way that no gaps should be seen in between the tables.

The main table shall be supported on 4 Nos. gable ends and a modesty panel. The gable ends shall be constructed out of 25 mm thick pre-laminated particle board finish as per approved shade. Modesty panel shall be made up of 18mm thick pre-laminated particle board finish.

The provision of 03nos. flower vase shall be as per manufacturer specification. Table shall be assembled as per design/ drawing at site in following configuration.

The seating system shall be decided by the engineer in charge with rectangular semi circular and quarter circle module.

Size : 4500 L X 900 W X 750 H (in mm) manufacturer products must be having following certificates ISO 9001:2015, ISO 14001 : 2015, OHSAS 18001: 2007, 50001 : 2011 (energy management system) , BIFMA & GREEN GUARD certified.

### Terms and Conditions:

All bills are to be accompanied by copies of purchase order and signed delivery challan. Payment will be made by A/c Payee cheque and no cash payment will be made under any circumstances. All payments are subjected to statutory deductions as and when applicable. Period of execution of work should be within one month from the receipt of the purchase order. If the supply/execution is not completed within the stipulated period as indicated in the purchase order a Liquidated Damage @ 0.5% per week will be imposed on the value of purchase order subject to maximum of 5% of the value of work order.

The vendors are requested to submit their quotations in sealed envelopes in the letter box of Prof. Sudipta Mukhopadhyay, Prof-in-Charge of Furniture placed in the 1<sup>st</sup> floor of Department of Mining Engineering, Indian Institute of Engineering Science and Technology, Shibpur Howrah – 711 103 by 4:00 pm of 01.02.2018. Tender No must be mentioned on the top of the envelope. This may kindly be noted that the rate to be quoted inclusive of all charges such as carrying cost etc., Taxes should be separately shown; rate should be valid for 6 months from the date of Quotation. The vendor must have PAN Card and GST Registration Certificate. **PAN No. and GST No. must be mentioned in the bid documents, without which quotation will not be considered.**
