INSTRUCTIONS TO BIDDERS:

The Successful Bidders will be expected to provide the above mentioned equipment subjected to the following conditions:

1. The above mentioned equipment will be hired by the undersigned on the event days i.e. 27th – 31st March, 2017.
2. Installations of the equipment should be done before 7 a.m. on 26th March, 2017.
3. Expert Technicians to operate the equipment should be provided by the vendor on both the event days.

The bidder shall provide qualification information which shall include:

- (a)
- (i) Copy of the Income Tax return submitted to the concerned I.T.O (at least for any 1 year of last 4 financial years)
 - (ii) Copy of PAN Card
 - (iii) Copy of Service Tax or VAT Registration Certificate (as applicable)
 - (iv) Copy of Valid Trade license.
- (b) Details of any litigation, current or during the last 3 years in which the bidder is involved, the parties' concerned and disputed amount in each case.
- (c) Copy of Proof of past experiences in working with any Government Organisation / Government Institute

Bid Price

- a) The bid shall be for the whole work including providing the equipment, installation on the venue, operation in the event days.
