At the outset, the Chairman extended a hearty welcome to the members and invitees present in the meeting and requested the Registrar to place the agenda items for discussion.

It is also resolved that all proposals approved/recommended in B&WC meeting will be placed in the Finance committee meeting for noting and/or for approval as the case may be and subsequently BOG as well.

The Chairman pointed out that in order to avoid any conflict of interest, the Building and Works Committee with nominee of CPWD be replaced by members from other organization as per statute clause no. 12(1)(vi) i.e. "one expert each from Civil and Electrical Wing of Central or State Government or any autonomous body of repute".

Presently the maintenance of entire Electrical Installation Works, a part of the Civil works and entire water supply system works are done by the PWD (Electrical), PWD (Civil) and P.H.E.Dte respectively. Members discussed in details regarding continuation of these maintenance works in the similar procedure in future. It was decided that the Institute Works Division will explore the possibility of undertaking these maintenance works by their own system or by CPWD or by any other organization or by the existing organizations and will place the proposal in the subsequent meeting of B&WC. However the current procedure of maintenance of above items may be continued till 30th Sept. 2019 by the PWD (Civil), PWD (Electrical) and P.H.E.Dte respectively.

There being no other agenda, the meeting ended with a vote of thanks to the Chair.
