- 3. The B&WC noted that at present the designation of the Institute Engineer is University Engineer
- 4. The B&WC further resolved that a Works Manual for Institute Work Division (IWD) would be prepared by the University Engineer in consultation with Dean IPM/Dean PD and be placed before the next meeting of the committee for consideration and necessary approval.
- 5. The B&WC observed that the Institute gets the works executed through PWD & PHED on deposit work basis as CPWD in the 1<sup>st</sup> meeting of the earlier Committee for Building and Infrastructure informed that they were not interested to be involved in renovation works rather they were interested for new construction work. In this context the B&WC suggested that gradually the Institute should engage the CPWD for execution of bulk renovation work. The B&WC also advised that the Institute may approach the DG/ADG of the CPWD in this regard.
- 6. However, the repair, maintenance works and minor works of renovation of the institute will be executed by the state PWD (Civil), PWD (Electrical), PHE, till the Institute Works Division is strengthened to do so or such work which CPWD or Institute Work Division is not in a position to execute the same with its present strength. All major renovation works of the buildings will be executed by the CPWD except those which has already been forwarded to PWD for taking action. Otherwise, If CPWD become unwilling then only state PWD (Civil), PWD (Electrical), PHE, or Institute Works Division will execute the works.
