#### .Resolution No.04.03:

The Finance Committee considered the note on selection of the security agency for engagement of about 87 security personnel per day (three shifts) at IIEST, Shibpur campus at an estimated cost of Rs. 2.92 Crore (plus other charges as applicable) per year.





In response to the queries of the members from the Ministry, the Registrar explained that the Institute has already outsourced security services for the Campus, such as Main gates, Hospital, Guest House, Library, Hostels etc. excluding the academic buildings for which the Institute's Durwans are already deployed. As the tenure of the existing security agency for deployment of 88 security personnel in three shifts is over and currently extension is being given from time to time, a fresh tendering of the security service is urgently required.

The Finance Committee further advised that the Institute should follow GFR and the CVC Guidelines in this regard.

There being no other items, the meeting ended with Vote of Thanks to the Chair.
