- The work should be completed within 20 days of issuing of order.
- A DD of Rs. 1000/- as EMD in favor of "Registrar, IEST, Shibpur" payable at Kolkata has to be submitted by the vendor/ supplier, without which quotation will be summarily cancelled. The EMD of the unsuccessful vendors will be refunded. The EMD of the successful vendor will be converted as performance security shall be valid until a "Period of Maintenance" for the work i.e 12 (twelve) months from the date of taking over possession. During the period of maintenance, the contractor will be responsible for rectifying any defects free of cost to the Employer.
- Materials & accessories supplied/used should be as per specification and of Approved Quality (B.I.S.) or by the authorised officer of I.I.E.S.T, Shibpur.
- The work should be completed within stipulated period as indicated in the work-order. A Liquidated damages @ 0.5% per week, subject to maximum of 2% of the value of work-order, beyond which the Employer may cancel the Contract.
- Bills in Triplicate should be presented for payment within 15days of supply/completion of work.

- All bills are to be accompanied by order copies and challans as received.
