This is for information of all concern that in reference to the Office Order No. 2481/D(AA)/17 dt. 05.06.2017. The Committee so formed with Prof. Aparna Dey Ghosh, President, Students' Senate being the Chairperson recommended that 10% each Full tuition fee waiver and Half tuition waiver are to be awarded to the existing 3<sup>rd</sup> & 4<sup>th</sup> year students from among the needy students with the income ceiling of the family being Rs.2.5 lakh per annum or less from all the sources. The Students eligible for tuition fee waiver would be ranked as per merit.

For the purpose of determining of Annual Income of parents/guardians of the students an officer of the rank of Block Development Officer or above in the district/their equivalent counterparts (Group-A Officer) elsewhere will be competent to issue income certificate to be issued to each such students.
