This is for information of all concerned that as per the resolution of the 9^{th} meeting of the Senate held on 04.01.2017, the registered PhD students who are not getting fellowships from the project fund because of the completion of the respective projects and seeking institute financial support to complete their Ph.D. work, will receive adequate financial support from the institute. However, in order to receive this financial support, the students will have to appear before an expert committee to be formed by the Director and will have to be selected by the committee as eligible candidates for financial assistance. The selected PhD students will receive financial support for a maximum period of (5-x) yrs., where x = no. of years for which the scholar has received project fellowship. The PhD students will be eligible for the financial support for (5-x) years or from the date of completion of the project till the time of the thesis submission, whichever is lower. However, the financial support will continue subject to the review of progress made by the scholar in every six months by the doctoral committee.
