### **THE SUCCESSFUL BIDDERS WILL BE EXPECTED TO PROVIDE THE ABOVE MENTIONED EQUIPMENT SUBJECTED TO THE FOLLOWING CONDITIONS:**

1. The above mentioned equipment should be made available by **5<sup>th</sup> March, 2018**.
2. All legitimate documents pertaining to the product must be supplied for future reference to the manufacturer of the product.

### **THE BIDDER MUST HAVE THE FOLLOWING QUALIFICATION:**

1. The bidder should provide Valid Trade Licence along with Company / Proprietor Pan Card as applicable.
2. Preference would be given if the bidder has submitted Valid Service Tax Registration/VAT Registration as applicable and also has an experience of at least 10 years in this business.
3. The bidder need to submit Documentary proof of Income Tax Return of at least one (1) year from last three (3) financial years.
4. Preference would be given to the bidder who has at least two (2) work orders of Rs. 1,00,000/- or above in a single contract for supplying materials to any organisation in last three (3) financial years or having prior experience of working with IEST, Shibpur or any government organisation (documentary proof to be submitted).
5. The bidder should submit duly signed and self-attested declaration that, the bidder hasn't been blacklisted by any organisation for performing below standard.

### **BID PRICE**
