The above candidates have to follow the following guidelines.

The candidate shall have to produce an NOC from her/his employer stating clearly that she/he shall be granted a leave of appropriate kind for the entire period of the PhD Programme (minimum three years) to enable her/him to undertake doctoral

research at the Institute; or the candidate should obtain an NOC from the University/Institute Authority granting her/him a minimum of six months' study leave to enable her/him to complete the course requirement at IIEST, Shibpur, which is a mandatory residential requirement.

The said University/Institute/Organization authority should also provide an assurance that after the six month's study leave, necessary permission shall be granted and facilities shall be extended to the candidate to carry out and complete her/his doctoral research at the parent University/Institute/Organization, under the guidance of a co-supervisor from the parent Institute/Organization, who has requisite qualification as approved by the Senate. If all the course requirements cannot be completed during the mandatory residential stay, the remaining may be completed through registering and qualifying the online courses approved by the Senate.

Candidates selected for admission, subject to fulfillment of the eligibility criteria for Ph.D. program July Cycle 2019 must report to the Office of the Dean (Academic) on the 1st floor Main Building with all original certificates for verification of documents during August 19-23, 2019.

Candidates are also required to submit the photocopies of all the certificates, four passport size photographs and original blood group certificate.
