SUMMARY

Strategic Management and Entrepreneurship have remained two common and prominent threads in my journey since 1997 – first in the corporate and then in academia. I was co-founder of one of the early e-learning ventures in India that later got acquired by global e-learning giant DigitalThink, Inc. As an interpreneur at NIIT Limited, I spearheaded 'learning managed services' that has now become the largest business division of the company. At Infosys, I was one of the key members chartered to build the Innovation Lab in promoting the culture of *innovation co-creation* within the company.

As part of my doctoral research at IIM Calcutta, I initiated, managed and researched on the transitioning of a leading Indian nonprofit to hybridism. The Ministry of Tribal Affairs, Government of India through its subsidiary $NSTFDC^1$ has been piloting "Community+" – a model from my research that demonstrated alignment with two recent Government of India initiatives - Start-up India and Stand-up India.

I am driven by *instrumentalist* epistemology – research that is useful for practice. My reflexive field based research studies have received seven national and international awards; the notable ones are - Academy of Management Best Paper (2017), PAN-IIM Best Paper (2015) and EFMD Best Case (2013). I have been the recipient of the SKS Best Doctoral Student Award at the 52nd Annual Convocation of IIM Calcutta (2017). My research, teaching and consulting interests situate at the intersection of *strategy*, *entrepreneurship* and, *organizational development & change*.

Since July 2017, as an Asst. Professor at SOMS – IIEST, I have been teaching two core courses – Fundamentals of Management (1st Year MBA) and Entrepreneurship (2nd year MBA). Apart from the regular academic (research and teaching) and administrative works, I have been entrusted by the SOMS management to work on five future possibilities for the school – elective course on *entrepreneurship* for B-Tech/UG, 5 year *integrated* B-Tech and MBA program, executive MBA, corporate training, and management consulting.

I co-founded and headed TCT Technical Training (India) Pvt Ltd. The organization was created in collaboration with a Silicon Valley based distance learning company known for its self-paced courses on telecommunications and computer training. TCT(India), during 1998-2000 was one of the top ten export oriented units (100% EOU) in West Bengal under the Software Technology Park (STP) Scheme of Govt of India. TCT(India) was acquired by DigitalThink in 2001.
