1. This project has been formulated at par with item nos. 14(b), (c), (d), (e) and (f) of the derailed break up of non-recurring expenditure proposed in Expenditure Finance Committee Note towards conversion of



Bengal Engineering and Science University, Shibpur to IIEST, Shibpur that has been subsequently approved by the Parliament of India.

The cost estimates of non-recurring expenditure proposed in Expenditure Finance Committee Note were firmed up as per the base year i.e. 2008-09 that have varied in the present estimates due to several reasons as stated under:

- Reconfiguration of capacity of students residential facilities as per the requirements arisen due to enhanced students strength and envisaged expansion of academic activities of the institute;
- ii. It was expected at the time of formulating the proposed non-recurring expenditure that additional land will available. In reality no additional land is available that have left no option other than high rise structure with normal consequence of high proportion of cost of construction of foundation @ of 40% of the superstructure;
- iii. Escalation of cost of construction to the tune of 262% over that of the base year of 2008-09 as per the specifications in the CPWD rates of schedule;
- iv. Additional provision over the project cost on (a) contingencies @ 3%, (b) Quality assurance @ 1%, (c) Service tax @ 15% on 40 % of the project cost, (d) Employees contribution on ESIC and EPF, etc.

Regarding the service tax component considered in the estimate, CPWD is requested to submit the latest notification on Service Tax Exemption (if any) for construction works in the Educational Institutions those are set up by Government.

- 4. Fund may be placed to the CPWD based on this estimated value and as per the MOU signed between the CPWD and IIEST, Shibpur (i.e., 10% of the estimated cost of the work at the time of A/A & E/S, 23.33% of the estimated cost of the work before award of the work and afterwards as per the cash flow requirement).

3. Regarding the preliminary estimate it is decided to exclude the construction of electrical sub-station form scope of the estimate as this work will be taken up separately under the up-gradation scheme for electrical power distribution system of the Campus. The provision of the AC in the Lecture Rooms (with 60% diversity factor) totalling to 1000 ton is considered much higher and to be reduced considering the provision for lesser nos. of class rooms and in limited areas of the laboratory spaces. The Committee advised to incorporate the revisions in the estimate as suggested above accordingly (#).

Regarding requirement of phase wise completion plan and corresponding estimates as suggested by the Director, IIESTS, it is envisaged that 1st phase of construction should include completion of the entire Lower Ground Floor and portion of the complex (say south east portion) above podium level. The rest portion of the complex above podium level may be completed in the next one/two phases.

Regarding the service tax component considered in the estimate, CPWD is requested to submit the latest notification on Service Tax Exemption (if any) for construction works in the Educational Institutions those are set up by Government.

- 4. Fund may be placed to the CPWD based on this estimated value and as per the MOU signed between the CPWD and IIEST, Shibpur (i.e., 10% of the estimated cost of the work at the time of A/A & E/S, 23.33% of the estimated cost of the work before award of the work and afterwards as per the cash flow requirement).
- 5. The CPWD shall take immediate action to complete the necessary soil investigation work and finalize the detailed design and drawings and estimate of the Building Project. The CPWD shall also finalize the design electrical load of the Complex in consultation with the IESTS at the earliest.
- 6. The PWD (Electrical Wing) is requested to reduce load from Sub-station-II in accordance to the already planned scheme by diverting the load to the Sub-station-II and finalize the necessary design and estimate towards up-gradation of the Sub-station-II taking into the consideration the design load of the proposed Lecture Theatre Complex in consultation with the concerned Committee of the IIEST, Shibpur.

Agenda Item No. 3,07:

To consider the recommendation of the project proposal of Rs. 70 Lakh submitted by BSOAT-IIEST, Shibpur Association (formed by the alumni batch of 1964 and 1960) for construction of Badal Sarkar Open Air Theatre at IIEST, Shibpur to be financed, designed and constructed by BSOAT-IIEST, Shibpur Association.

Resolution No. 3.07:

The Committee noted the following:

On 12th June, 2014 BEC 69, the 1969 alumnus of B. E. College, Shibpur made a proposal for 'Badal Sarkar Open Air Theatre' to be constructed within the earmarked location inside the IIEST premises. A presentation on the complete architectural and engineering design was then prepared by expert technical team of BEC 69 batch.

The Executive Council in its 44th meeting held on 02.07.2014 (vide resolution no. 44.07.01) approved the proposal of Sri Jayanta Pradhan, President of B. E. College 1969 batch, regarding construction of 'Badal Sarkar Open Air Theatre'.

As per the above resolution an association was formed with members from BECA 1964 and BEC1969 in the name of 'Badal Sarkar Open air Theatre, IIEST, Shibpur'. The body so formed has already been registered.

A five members committee was constituted by the Director vide office order no. RMS/5151/16 dated 24.05.2016 (copy attached as Enclosure-1) under the chairmanship of Prof. Aditya Bandyopadhyay, Professor, AT & RP and Dean, IPM to go through the technical aspect of the project Badal Sarkar Open Air Theatre and to



advise the Architect and structural engineer engaged by BSOAT-IIEST, Shibpur Association for submission of a comprehensive report and to vet the project for placing it before the building committee for approval. The committee would also monitor the progress of the construction work and oversee the construction work as per the design on behalf of the institute. The committee met on 23.06.2016, 13.02.2017, and 24.02.2017.

A comprehensive report with detailed drawings both Architectural and Structural along with estimate of Rs. 70 lakh was submitted by both the Architect and Structural engineer incorporating all the suggestions. In the meeting of the Technical committee held on 24.02.2017 the project was vetted. Detailed drawings both Architectural and Structural along with estimate are enclosed as Enclosure-6.

It is mentioned in the report that, in order to phasing out the stages of construction it is desirable to divide the PHASE I work in two. One being the construction of the stage and back-stage portion and other being the gallery for 950 viewers with toilet facilities under the gallery as envisaged in the PHASE I of Concept Plan. Of these, estimated cost of construction for the stage and back-stage portion will be Rupees seventy lakh approximately and that for the Gallery with toilet facilities will be approximately Rupees one Crore thirty-five lakh.

The construction of PHASE II which will come up at a later stage will consist of an extended gallery accommodating additional 980 viewers. The portion below the gallery will accommodate other recreational and cultural activities like film screening, rehearsal areas, archive, and seminar rooms for different activities. The estimated cost of construction will be approximately Rupees one Crore eighty-eight lakh.

Members of the Technical Committee vetted the project and signed all the documents to place the project for consideration and approval of the appropriate authority.

The Committee has considered the Report submitted by the Technical Committee and approved the same. It was also resolved that the recommendation of the committee will be sent to the Committee for Financial Affairs and to the BOG for their consideration and approval.

The meeting ended with vote of thanks to the Chair.
